Under no circumstances should the Defendant be in a position of power and authority over children.

The Defendant's residence, changes and any co-habitants must have prior approval of the Probation & Parole Officer. The Defendant will not reside in a residence where there are any children under the age of 18 without the written approval of the therapist and the Officer. The Defendant will not have a cell phone, or such other technology/device, with photo, video, or Internet capabilities allowed. If a cell phone is used, all bills and records will be made available to the Probation & Parole Officer. The Defendant shall submit to annual polygraph testing. The Defendant will not date, live with, or otherwise be aligned with any person with children under the age of 18 without the express prior approval of the therapist and Probation & Parole Officer. If this approval is granted, they shall both be involved with the Defendant's treatment to the extent recommended by the treatment provider.
