I shall not reside in a residence where there are any children under the age of 18 without the written approval of my therapist and Probation/Parole Officer. 7. I shall not access or possess any material that describes or depicts human nudity, the exploitation of children, sexual acts including but not limited to computer programs, photographs, drawings, video or audio recordings, magazines, books, literature, writings, etc. I shall not frequent adult books stores, topless bars, massage parlors or use the services of prostitutes. 8.
